INGREDIENTS

Water, Thickener: Erythritol, Arginine hydrochloride, Natural flavors, Thickeners: Xanthan gum and cellulose gum, L-citrulline, cocoa (Theobroma cacao L.) seeds d.e. tit. 10% theobromine, goji (Lycium barbarum L.) fruits d.e. tit. 50% polysaccharides, Preservative: potassium sorbate, Acidifier: citric acid, chard (Beta vulgaris L.) root d.e. D/E 4:1, schizandra (Schisandra chinensis (Turcz.) Baill.) fruit d.e. D/E 4:1, mate (Ilex paraguariensis A.St.-Hil.) leaves d.e. tit. 1.5% caffeine, Sweetener: steviol glycosides from Stevia.
